Hear comments on a proposed request to combine two lots together located 2906 & 2908 S. Hwy 36 legally known as Lot 3 Block 1 Cummings-Pruitt Addition 1.426 acres and Part of Lot 6 Block 28 Southeast Annex .5 acres for the purpose of selling as Business Commercial Property

City Manager William H. Parry III said that these two lots are located on Highway 36 headed towards Temple and are owned by Joyce Pruitt. Ms. Pruitt is requesting to combine these two lots into one piece of property with the intent on selling as a Business Commercial property.

City Manager Parry stated that this request is from the City of Gatesville to re-plat and rezone a parcel of land located at South 10th Street also known as the Old City Gym lot.

The two pieces of property- one of which formerly belonged to the Gatesville Independent School District- that are requested to be re-platted and rezoned would combine into one lot and be rezoned from Community Facility to Single Family Residential with the purpose then to be put up for sale.

The Planning and Zoning Commission met on May 8, 2017 and unanimously voted to approve the City's request to re-plat into one piece of property and to rezone from Community Facility to Single Family Residential.
