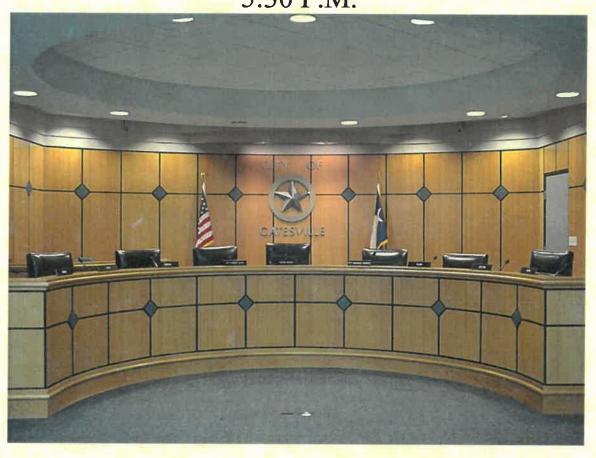

David Bullard, of 614 Golf Course Road, Gatesville, spoke to Council regarding sewer issues that he has had since Luis Lobo was employed with the City of Gatesville, but has since retired. Mr. Bullard stated that his sewer had previously been on septic tank and was hooked up to a grinder pump years ago but still has problems. The last city manager was going to run lines to the back of his property and hook up him & several other houses in the area around him but it never happened and now that city manager has retired. Mr. Bullard stated that he can't sell his house because of the sewer issues including the constant smell. His two neighbors that are on septic tanks are also having sewer issues. Mr. Bullard asked for the Council's assistance to fix this issue.

Next, Julie Jones- Horan, of 501 South 6th, Gatesville, spoke to the Council about Faunt LeRoy Park. Ms. Jones- Horan said that she has lived here her entire life and is upset that the park has become in such disrepair. Ms. Jones- Horan expressed her and her neighbors concerns of being affected by the neglect of the park. She has observed limbs that are hanging from trees which are dangerous to all park goers. Ms. Jones-Horan asked the Council to use the FEMA funds that were approved for Gatesville as intended and fix the park. Ms. Jones- Horan thanked the Councilmembers for listening to her and thanked them for their service to the community.

6) DISCUSSION AND POSSIBLE ACTION REGARDING A PROFESSIONAL SERVICE AGREEMENT WITH FREESE, NICHOLS, INC. (FNI) TO ASSESS THE CITY'S VULNERABILITY TO A CYBER-ATTACK ON THE CITY'S WATER SYSTEM AND FORMULATE A SUPERVISORY CONTROL AND DATA ACQUISITION (SCADA) BUSINESS PLAN, VULNERABILITY ASSESSMENT, AND A PROJECT LIST AIMED AT BOLSTERING THE CITY'S DEFENSES AGAINST POTENTIAL CYBERATTACKS ON THE CITY'S WATER INFRASTRUCTURE. City Manager Albert asked the Council that agenda item # 6 be pulled from the agenda and to schedule to be on the March 12th council meeting agenda. Mr. Albert said that he had been unable to get all the needed information to present to Council and had reached out to other vendors/firms as directed by council, but hadn't heard back from anyone yet.

## 7) <u>DISCUSSION AND POSSIBLE ACTION REGARDING THE FINANCING OF A USED VACUUM TRUCK FOR UTILITY OPERATIONS.</u> (SCOTT ALBERT & ROBERT BUSTER)

City Manager Albert said that staff was requesting authorization to finance the purchase of a used vacuum sewer truck for utility operations as the city's vacuum truck was left outside with water remaining in the tank during the recent freeze which resulted in significant damage to the vehicle. To repair the truck would cost a minimum of \$50,000.00 and there was no guarantee of repair because the parts for the 1999 truck are nearly impossible to find. To purchase the used vacuum truck the city would enter into a five (5) year finance agreement with Government Capital Corporation with an approximate annual payment of \$46,840.95 and a fixed interest rate of 5.706%. Mayor Chumley noted that this is a very good interest rate since it would be considered an unsecure loan. The first payment would not be due until the next fiscal year in February of 2025.

Wastewater Treatment Plant Supervisor Robert Buster answered questions regarding sale of the old truck for parts and the proposed purchase of the used 2015 vacuum truck and that it has a warranty until 2025. Mr. Buster said that a vacuum truck is a very important piece of equipment and is used nearly everyday as it is very useful for a variety of purposes. If Council approved this purchase, the vacuum truck could be picked up right away. It was noted that this vacuum truck has a winterization kit included.

<u>RESOLUTION 2024-15</u>: Motion by Barbara Burrow, seconded by Joe Patterson, to approve and authorize the City Manager to enter into a finance agreement for the purchase of a used vacuum truck for utility operations at a cost of \$195,000.00; Burrow, Casey, Patterson, and Rainer voting "Aye", Westbrook abstained, motion passed.

Agenda Item: Discussion and possible action regarding Financial Advisory Services.

### **Information:**

Currently the City's Financial Advisors (FA) services are provided by SAMCO. FA's are utilized when issuing debt, refunding debt, and ongoing reporting of debt related information to the public, Federal agencies, and the bond holders. An FA continually monitors our debt issuances and the bond market looking for savings opportunities. FA's also assist when a debt issuance is needed to fund a major City project and will provide analysis and recommendations of the most cost effective method of funding the project.

### **Financial Impact:**

The proposed contract with PFM Financial Advisors LLC (PFM) is on a fee per use basis, without any minimum, or recurring costs. PFM will provide in their presentation and analysis of savings on future debt issuances and refunding's from our current FA SAMCO. Our current FA charges us more than \$4,000 for our yearly required filing with EMMA, which is March 31st of every year. PFM offers this service for free as part of representing the City as our FA.

### **Staff Recommendation:**

The staff recommends that the City Council approve PFM Financial Advisors LLC to provide Financial Advisory services to the City of Gatesville

Agenda Item: Discussion and possible action regarding credit card and convenience fees.

### Information:

Currently the City absorbs the costs associated with accepting credit cards. In an effort to make it more convenient for the public to pay for services, fees, and fines; the areas where credit cards are accepted through the city has increased. Accepting credit cards has also reduced our risk of fraud by accepting and transporting less cash in remote locations. Payment of utilities is available by web or phone, and there is a per use fee associated with each transaction. The City is one of few businesses in town that do not pass along the additional costs associated with credit cards. The County adds an additional fee for paying by credit card as well. Staff recommends passing the additional costs associated with credit cards to the public in March, or as soon as practicable thereafter. This will give us time to give notice to the public.

### **Financial Impact:**

As of the first quarter, the City has paid over \$26,000 in credit card and convenience fees. This is due to accepting large payments by credit cards for Hotel Occupancy taxes and the per transaction utility fees. These added expenses will continue at this pace unless policy is changed.

### **Staff Recommendation:**

The staff recommends that the city council approve adding a convenience fee to all credit card transactions effective in March 2024.
